Canon Mother's Day Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility: The Canon Mother's Day Sweepstakes ("Sweepstakes") is open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older, physically located and residing within the U.S. at the time of entry.
