

Canon Mother's Day Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

- 1. Eligibility:** The Canon Mother's Day Sweepstakes ("Sweepstakes") is open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older, physically located and residing within the U.S. at the time of entry. Void elsewhere and where prohibited by law. Employees, contractors, directors and officers of Canon U.S.A., Inc. ("Sponsor") and their respective parent, subsidiary and affiliated companies, distributors and licensees, and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of the Sweepstakes (collectively, "Promotion Parties"), and their immediate family members (parent, child, sibling and spouse of each) and those living in the same households of each (whether related or not) are not eligible to enter or win.

You will need an active Instagram account (an "Account") to participate in this Sweepstakes. If you don't already have an Instagram account, visit www.instagram.com to create an account; creating an account is free.

By submitting a Sweepstakes Entry, you consent to receiving emails from Sponsor and/or its licensees and assignees relating to the Sweepstakes. Consenting to receive promotional emails is optional and does not have to be agreed to in order to enter the Sweepstakes and does not improve your chances of winning. **FOR MOBILE USERS** - this sweepstakes may not be supported on all mobile devices. **Data rates may apply.** You will be charged according to your mobile phone service provider's rate plans. Any attempt to make more than the stated number of Sweepstakes Entries by any method may void all Sweepstakes Entries from that entrant. Anyone found using multiple mailing addresses to enter the Sweepstakes will be disqualified. Incomplete Sweepstakes Entries, including but not limited to those Sweepstakes Entries that do not address the requirements set forth in these Official Rules, will not be eligible. Proof of sending does not constitute proof of actual receipt by Sponsor for purposes of these Official Rules. 4. **Random Sweepstakes Drawing:** On or about May 12, 2025 following the expiration of the Sweepstakes Period, Sponsor will randomly select three (3) potential winner from among all valid entries received, subject to verification and compliance with these Official Rules.

The odds of winning depend on the total number of eligible entries received during the Sweepstakes Period. Any difference between the stated ARV and actual value will not be awarded.

defined as the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational, institution, etc.) responsible for assigning email addresses for the domain associated with the submitted email address.
